The undersigned _____ (“Student”) and/or parent/legal guardian(s) of Student, hereby consent(s) to Student’s participation in the Youth Basketball Camp (“Activity”).

I am/We are fully aware of the risks and hazards connected with the Activity, which I/we understand could lead to bodily injury to Student and/or, among other things, loss or damage to Student’s property. In consideration for allowing Student to participate in the Activity, I/we hereby release, discharge and hold harmless St. Mary’s High School; the Catholic High School Association of the Archdiocese of St. Louis, Missouri; the Archdiocese of St. Louis and all of their respective employees, volunteers and agents (hereinafter referred to as “Releasees”) from any and all liability, claims, demands, actions and/or causes of action whatsoever arising out of or related to any loss, damage, or bodily injury that Student may sustain, or to any property which I/we own or Student owns, whether caused by the negligence of the Releasees, or otherwise, while participating in the Activity, or en route to or from the destination where the Activity is being conducted, provided that this release and hold harmless shall not apply to the willful misconduct of the Releasees. In the event that any action or claim is brought against any Releasees from all of their damages and costs, including attorney’s fees resulting from such action or claim.

Should it be necessary for Student to return home due to medical reasons, disciplinary actions or otherwise, I/we agree to assume all transportation costs.

In case of medical emergency, I/we, the undersigned, do hereby request and consent to examination and treatment of Student by any duly licensed medical professional or health care facility, and further accept full financial responsibility for charges for same, including ambulance charges.

About Coach Turner

Coach Bryan Turner will begin his first season at St. Mary's High School with the start of the 2017-18 season as the Head Basketball Coach. Prior to being named Head Coach at St. Mary's, Turner served as the Assistant Coach under the direction of Coach Kelvin Lee from 2015-17.

Turner has had the pleasure of serving as Head Coach for several high schools during his coaching career including Gateway STEM High School where he led the Jaguars to a PHL Conference Championship, a Class 4 District Championship and a State Quarterfinals appears in 2013.

Turner also served as Head Coach of his Alma Mater Beaumont High School. As a student-athlete he enjoyed a stellar career at Beaumont from 1996-2000. Turner graduated as the school's career-leading scorer before going on to enjoy an excellent career at Southern Illinois University-Carbondale where he helped the Salukis to two NCAA Tournament berths.

Coach Turner believes that basketball is a privilege not a right for student-athletes. Excellence is the standard on the court, in the classroom and the community for the St. Mary's Basketball program. Academics prowess is the main goal for Turner.

"Basketball is an extension of the classroom. Though basketball is a game it also is a teaching tool for young men and women to be productive people, sons, daughters, husbands, wives, fathers, mothers, friends and citizens in society," said Turner, a native of St. Louis.
